- A member of the public inquired about the decision-making process regarding their admission to the finance meeting.
 - Response from UTC There was a misunderstanding of the rules, leading to the Clerk consulting the Standing Orders before admitting the member of the public.
- A meeting attendee questioned the reasoning behind the decision to invest in professional advice for staff payroll and VAT, considering the availability of guidance from One Voice Wales, an organization dedicated to advising councils.
 - Response from UTC The cost of the VAT advice will be covered by MCC, and the staff payroll check will be provided at no charge.

20.2 County Councillors participation - Meirion Howells (MH), Tony Kear (TK)

- Green Infrastructure enhancement schemes MH reported four areas have been identified in Usk the committee will report back to UTC
- Ash dieback tree removal works are currently being carried out by MCC.
- MCC has been notified of 10 potholes that require attention.
- Installation of 20mph signs near Usk Athletic Club has been completed.
- Resurfacing work has been completed on the approach to the A449.

- The bus service in Usk has undergone a retendering process, resulting in an hourly No 60 bus, a Sunday service, and an improved service between Nos 60 & 68 starting April 1st.
- The bus stop sign at Burrium Gate has still not been reinstalled.
- Speed watch there has been revised risk assessments in light of the new 20mph legislation. The group look to undertake more reviews
- MCC now has the capability to download data from SIDS, although it is not yet accessible.
- There is a lack of activity in maintaining drains to prevent flooding
- As a Ward Member TK expressed dissatisfaction with the lack of publicity surrounding lowcost home ownership opportunities in Usk
- MCC will conduct a review of road conditions and repairs, implementing a new grading system to prioritize roads for maintenance
- Following complaints about portions and waste, the Head Teacher is conducting a survey on school meals.

Renewal of UTC/Sessions House Insurance

Resolved: Cllr Ivin had contacted Insurance Brokers Thomas Caroll for a competitive quotation but has not received a reply. Therefore, it was agreed by Full Council to proceed in accepting Zurich's quotation for a fixed price 3-year policy at £3,865 per year.

Ongoing VAT issues - Cllr Ivin to meet with Centurion for VAT Guidance. Cllr Ivin has requested staff submit pay slips from November 2023 to 2024 for the purpose of engaging an independent payroll company.

20.8 To consider MCC's countywide forthcoming parking review

During the summer, MCC will conduct a review. TK reported that UBSEG had discussed parking and the majority were in favour of 2 hours free parking.

Resolved: Cllr Howells will work on creating a survey for residents. Additionally, it was noted that the Memorial Hall committee has formally requested designated parking bays from MCC for Memorial Hall users. This request will be included in the countywide review.

UTC Events committee is considering a summer event – Usk Young Farmers have been approached to see if they may be interested

Christmas Festival – UTC still waiting to see what involvement (UBSEG) propose.

TK made UTC aware of the Community Ownership Fund. This fund helps community groups buy or renovate assets that would otherwise be lost to the community.

Resolved: TK will discuss with Craig O'Conor, MCC to gain clarity on the process and associated costs involved in acquiring the clock as an asset.

21.6 To discuss concerns raised by a resident regarding crossing the road at the Porthycarne St, Bridge St, Maryport St junction

The matters was discussed.

Resolved: Concerns raised by the resident, will be addressed within the context of the new development proposals. The consultants will incorporate these concerns into the consultation plans.

21.7 To discuss concerns about the dangerous parking in Four Ash Street

This matter had been raised with Inspector Sowrey prior to the meeting. Lines and signs are being considered for this area but will be included in the 2024-25 budget. **Resolved:** MH will ask residents about displaying 'no parking signs' on their premises to discourage parking.
