Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2025 of **Usk Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis of Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement fairly present the Council's income and expenditure and financial position:

- The Council has not provided explanations for significant variances within the financial year.
- The Council has not provided a properly completed bank reconciliation as at 31 March 2025.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Fixed asset figure stated as 'in progress' in the 2023-24 financial year's column

The fixed asset figures on the annual return stated, 'in progress'. We believe the figures for line 12 should have been £300,514 for 2023-24 financial year, as was stated on a separate draft version of the annual return provided to ourselves as part of the 2023-24 financial year's audit.

Re-statement of creditors' figure

The Council has re-stated its creditors' figure on its annual return. The Council has not disclosed that it has re-stated this figure. The Council must make a disclosure when re-stating its figures and make it clear which figures have been re-stated on the annual return.

General lack of information provided

Each year we send the Council an audit notice that sets out the information we need to complete the audit. Failure to provide this information may lead to a qualified audit opinion and potentially an increased audit fee.

We recommend that the Council reviews the annual audit notice to ensure that all required information is provided on a timely basis.

There are no further matters I wish to draw to the Council's attention.
