The Cricket Club fence remains unsightly and in need of repair

It was reported the incidence of fly tipping has increased since closure of the UHRC. **Resolved:** Members to put together a report supporting the continued opening of the UHRC

27.3 To receive an update on the Master Plan for Usk

No further meetings have taken place.

Resolved: UTC has given much thought and consideration to the varied views and comments of residents regarding the proposed re-routing of the A472. UTC also took the advice of both MCC officers and ARUP and as a result, it was unanimously agreed, that the proposed one-way system was not viable. **Resolved:** UTC to remove the option from the Plan.

Residents will be asked to takedown the notices regarding the re-routing currently displayed around Usk

Resolved: Cllr Williams & Howells will progress this further when able to do so

Resolved: Work appears to be on going

b) The Priory Gatehouse

Resolved: The Clerk has been in correspondence with Mon CC regarding the state/safety of the Gatehouse. An email has been written to Jonathan Morgan Heritage Officer, stating that not only UTC, but residents consider the current state of the Gatehouse to be unacceptable.

The correspondence highlighted the Gatehouse is a prime building in the town where people worship, attend marriages, and say farewell to the deceased.

UTC expressed concern, that if nothing is done to end the disrepair of the Gatehouse, it will remain in its current state for years to come, with the fencing being a permanent eyesore. UTC consider the only way to resolve this is for Mon CC to oblige the owner to repair the damage and to then remove the fence

27.9 To receive a report on the Mayor's Fundraising

Cllr Wilkinson reported that to date, she has raised £4000 towards her chosen charities

28.0 To discuss the Alfred Russel Wallace statue application

Planning application for the ARW statue has been agreed by Mon CC.

However, there is an issue with the street licence application. This can only be applied for by UTC, who would as a result, be required to take ownership of the statue. The Heritage Lottery Grant would then have to be applied for by UTC, which, may jeopardize UTC application for Sessions House restoration grants **Resolved**: This matter to be explored further by Usk Civic Society
