## 11.6 County Councillors participation

Cllr M Howells

- 1) Active Travel route proposed along Factory Lane to the School. Plans to be drawn up for further engagement
- 2) Faded lines on roads reported outside The Legion, Church St, One Stop corner, all along the A572 and Maryport St.
- 3) UTAG meeting with MP and MS. Transport for Wales has identified Usk as one of their Pathfinder locations. Political parties have shown interest in this development going ahead.
- 4) Air Quality reports are showing improvement, with Nitrogen Dioxide level readings going down; 6 locations on Bridge St and 3 on woodside have all reported lower than previous years. # 12.4 To receive an update on the Masterplan for Usk

## Cllr M Howells

MCC are currently developing a plan to be agreed that it goes to consultation with residents. If agreed it will go to consultation on 24<sup>th</sup> October 2024 for 6 weeks. Recommendations can then be made on the results of consultation which will go to a Spring 25 vote on whether to take the deposit plan to Welsh Govt. The plan would be to develop 2,130 homes in Monmouthshire by 2023.

In Usk the proposal to develop 40 homes on the roadside by Burrium Gate is on the deposit plan. The administration are adamant that all homes must be net zero construction and sustainability. Half of them (20) must be affordable homes that is social rent or on shared ownership. Cllr Howells' survey is available on his Facebook page.

## Cllr K Peacock

A lot of concerns were raised a recent meeting by Burrium Gate and Castle Oak residents about the excess water that collects there and comes out onto Monmouth Road. Their concerns need to be addressed and what the impact will be on the drainage systems. The system they have in place is not coping with the water at the moment – 100,000 litre tank.

New residents will bring more vehicles to the area impacting on parking near the shops and services in the town.

#### Cllr A Ivin

The viability of this seems unlikely, with zero carbon and 50% affordability.

## Cllr G Howells

People are mostly objecting to the risk of flooding more than the houses themselves.

#### Cllr M Howells

There have been more designs on sustainable drainage systems and policy is that any site over 100 square metres must show that it's better than what's there, which is basically a sponge at present, so it has to be better than that before development can take place. This is being addressed.

#### Cllr A Ivin

We're still waiting for the results of the Road Survey. This has been delayed several times and should have been delivered end of September. Apparently MCC have had some data but came in a format that was unreadable to anyone that wasn't a traffic specialist so they have requested an executive summary. We have requested we meet with the traffic consultants to ask questions directly about the results. Next meeting will be end Nov/beginning Dec.

# 12.5 To receive MCC's countywide forthcoming parking review

#### Cllr M Howells

Consultants have been appointed and there will be engagement with communities, businesses, town councils and community county councillors. No dates set. If proposals for change emerge there will be a public consultation. The survey shared at the last meeting had 1,656 respondents, 93% (1,537) requested that parking remains free, 6% (108) said it should be charged.

By the end of this year all yellow lines and blips outside the One Stop should be complete by the end of 2024. These will be monitored by the Traffic Enforcement Team, there are five of them covering the county, we have 2 officers for 2 hours a week. They are looking to recruit one extra and there are currently 2 officers on long term sick leave.

Sports Wales have offered £100,000 not the £125,000 requested but we still have option of Crowd Funding to give some resident involvement. We've got£25,000 self-funded including the £20,000 from REET. There is scope to reduce the size of the Pump Track.

The REET fields company are working to put a lease together. The Athletic Club are relinquishing part of their lease on the area so that can facilitate the Pump Track lease.

Funding requirement is that work starts by March 2025 and is completed by September 2025.
