# 3. To approve the minutes of the meeting held on 8 January 2025

# 4. Matters arising from meeting held on 8 January 2025

Still waiting on response from CADW for reimbursement of certain monies spent on the Sessions House repairs and professional fees. Forms submitted to CADW.

## 5. Authorisation of payments online/cheque - Bank Reconciliation.

Members received copies of the payments & receipts for the month No queries - all agreed.

No payments were made outside the normal monthly running costs or not previously agreed. All payments are being made by BACS and Direct Debit.

#### 6. To approve the following payments:

**a.** Payment to Newport Bus – payment of £103.31 for loss in bus revenue approved for payment, subject to Cllr M Howells having one further attempt to secure that MCC pay the bill, as the additional traffic management required by MCC and paid for by UTC was unnecessary as the buses were unable to run even with those measures.

# 8. To discuss the 2025/26 Draft Budget and precept for 2025/2026

Following lengthy and detailed discussion on each item of predicted expenditure and anticipated receipts, the draft budget was confirmed with a precept rise of 7.73% for 2025/2026 giving a precept for the year of £186,500.

#### 9. Training

# 10. Matters of Information/ Any other business.
