3.9 County Councillors participation

County Cllr Kear

Monmouth Road: Resurfacing will be completed this week. Road closures will be 3rd, 4th and 7th July 9.30am-3.30pm. With 7th July as estimated finish date. There will be delays but access for residents. The request that one side of the road was done at a time was rejected as deemed unsafe.

The requested for a dropped kerb was also rejected due to insufficient size of pavement.

Speeding concerns here; plans with GoSafe have been suspended until work is done. The GoSafe van will need to gather data as the investigation needs to be statistically driven.

Resurfacing Porthycarne Street / Abergavenny Road:

This is scheduled for Autumn 2025 and will go up to the end of the wooded area.

Following a GAIST survey Chepstow Road will also be looked at. A town pavement survey has also been carried out.

Usk Bridge Damage: This has now been rebuilt, the current traffic lights will be removed soon.

ACTION: Cllrs Kear & M Howells will request traffic lights are removed as soon as possible.

UTAG project: The meeting with Ken Skates has been rescheduled for 10th July

Bus Stop: Christian Schmidt has agreed that this will be on the schedule.

Proposed Path Order – Usk Athletic Club

Proposal to move the footpath from the Pitch to behind the tennis courts.

UTC raised a query with Gavin Pugh, MCC Rights of Way Officer, about the prospect of the path being used by cyclists with the proposed Pump Track development. Mr Pugh made it clear that the plan is for a pedestrian right of way only. The pump track would have to apply for a cycle order.

Planning meeting voted for the order with 2 Cllrs declaring an interested and not voting, 1 councillor absent from the meeting. Motion was passed with a majority.

APPROVED

Cllr A Ivin wished to make some comments about her 2 objections even though it would not change the vote;

- 1) The footpath is 1.45m at present, Mr. Pugh's cover letter refers to 3m, but the draft order refers to 2m. Having spoken with Mr. Pugh, he has said it will be increased to 3m, so it would have to double in size from what it is now.

It's been mentioned that a cycleway in that position is essential for the pump track to go ahead; that the pump track has three available routes of access to it, one being down the river, one being down the continuation of Maryport St (which has already been discussed several times in terms of the danger there and active travel), so the safest route is the third route which is the route behind the tennis courts. Cllr Ivin foresees sequential applications being made, first to move the footpath and then pump track access later, and there will be an application to allow cycling on that pedestrian route. Due to physical constraints there, you won't have enough space to have shared use. Cllr Ivin is not in favour of shared spaces.

Chair stated that this is an issue for pump track in the future and MCC should investigate safer access points for the pump track.

- 2) The footpath of the cricket field has been in use for a very long time when people have been straying and perambulating around the cricket field and a better outcome for the town would be that pedestrians stay on the cricket field and the cyclists go down the new path behind the tennis court.

Traffic Modelling Review

Meeting held last week with the approach to resume design and development of Twyn Square and Bridge St while maintaining traffic flows, prioritising pedestrian experiences between accessibility and placemaking. Retaining the bus access to Twyn square with a parallel exploration of alternative and additional stopping point options. Roberts Limbrick has been requested to resume design works. Dan and Clare will be having a meeting at the end of the month.

Shared Prosperity Fund

Cllrs were requested if they were interested in responding to this offer. Cllr Ivin is having trouble with time lag on emails.

Agreed that Cllr Howells would share an expression of interest.

Cllrs reported that the traffic enforcers have been in town issuing charges. Cllr Kear has spoken with Paul Griffiths about the ineffectuality of the lines without enforcement and has sent photographs of the new lines to Dan Fordham who has assured him that enforcement will recommence.

Usk Together for the Climate

Himalayan Balsam Bashing party along the brook that leads down to Ty Melyn, along the Abergavenny Rd, took place on 8th June.

A group attended the UWE presentation showcasing their project of Sustainable Usk 2050. Their project showed eco-friendly, adaptability for flooding and housing, green transport, a resilient infrastructure with local source of food, walkways over the river embracing that the river floods and where it would be allowed to do this with an additional southern bridge. It has been requested that the students bring it down in the autumn to give presentation councillors and residents.

UBSE are disappointed that the group are disappointed that UTC are not able to support a summer event. Cllr A Ivin confirmed that UTC proposed to support one event or 50:50 2 events, as per budget.

In response, Cllr Kear reiterated the disappointment from the group due to struggling businesses and closure of businesses in the town and that the footfall and publicity that events generated are beneficial to the town.

5.0 To discuss the use of the former Usk Household Recycling Centre (UHRC)

Cllr M Howells has spoken to Emma Bevan, an artisan crafter, hoping to hold craft fayres there.

Chair is going to approach the shopfitters to ensure that they clean up before UTC take on the lease.

5.1 To receive an update on the proposed pump track

Chair requested a schedule of actions for the development of the track.

County Cllr M Howells

UPT Committee are awaiting the results of the preliminary ecological report to see if any further ecological studies, if any, are required prior to planning application.

REET will reimburse the setting up for the lease, enough funding is available for this to go ahead.

Cllr Ivin asked for clarification about access to the track. Cllr M Howells said this would be explored and does not anticipate a great deal of people using it any one time. Looking at Gilwern, as an example, a few families use it at weekends and parents with toddlers in the week. Cllr G Howells asked why so much money being invested in it if it wasn't going to be well used. Cllr M Howells explained that pump tracks provide a gateway to cycling. Every child in Usk will have the opportunity to use it and learn to ride there; British Cycling and Sports Wales are encouraging them for communities all over the country.

1. A dead tree on Abergavenny Road opposite Ty Melyn.
2. A professional dog walker has been letting several dogs run free off leads on the REET field and dogs' mess not being collected.
3. Do the double yellow lines at the Lamb and Flag corner on Maryport St need to be so long?
Cllr M Howells explained that this has previously been investigated as a possibility to free up 2 extra parking spaces, but the lines are necessary because of the opposite junction to Priory Gardens.
