Question 1: Bins outside No.49 – has this been resolved?

MCC have not been answering questions around this.

Council agreed to pay a Land Registry Disbursement cost of £7 +VAT to establish ownership of the land. Total cost will be £14 +VAT

Question 2: Publication of the audit; will this be on 30th September or delayed?

Cllr A. Ivin replied to this explaining that last year there were a lot of queries arising that needed addressing and it will be submitted by 15th October. Extension of time was given due to the acknowledgment of changes in practice in 24/25 audit. Both internal and external auditors agreed it would b4e sensible to use an extension this year. After submission and auditors' responses have been received, the audit will be published to the noticeboard and the website.

9.1 County Councillors participation

County Cllr M. Howells

Abergavenny Rd Road Works: Work to commence 29th September. Resurfacing will take place in 3 phases. Phase 1: Llancayo, Phase2: Abergavenny Road to Usk Vets, Phase3: Porthycarne St to Bridge St. There will be access for residents. To minimise delays at rush hour, work will be between 9.30am and 3.30pm.

Castle Oak Pond: work has been carried by Green Infrastructure on the management of this area. Other ponds are in planning process.

Usk Railway Bridge: Wales and West have finished their works, and the bridge has been reopened. **Bus Services**: A new timetable is available with additional services added. The last bus to Newport is 9:50pm and last bus to Monmouth is 8.40pm.

MyTravel Pass: available for young people aged 16 - 21 enabling them to travel for £1 a journey. From November this will be available to younger children. Available from Transport for Wales.

RLDP Place Scrutiny: Scrutiny will take place on 25th September. 4,000 responses have been received, and each had to be responded to. The report will come out before 25th.

Flooding Consultation: Consultation currently running, public are invited. Issues over blocked drains were raised. These can be reported via MyMon app.

Island Play Park: Maryport St Park was assessed but the Island Park wasn't assessed. No work has been undertaken for the last 8 yrs. Cllrs Kear and Howells have challenge the study and have since arranged for cleaning and painting to be done by MCC. Further fundraising will be need to add more/replace equipment.

Abergavenny Rd Speeding: Speeding has been an ongoing concern on this road. As part of the road works, this will be addressed. Ther will be a prioritisation of traffic at the railway bridge which will mean traffic meeting will have to give way on one side. White lines will not be replaced outside the houses; psychologically without lines, traffic slows down.

Speeding at Burrium Gate: Tubes have been laid to collect data. The tubes on the left came out on 3 occasions due to either vandalism or soft tarmac. Data will be redone to understand the extent of the problem. GoSafe team has changed so meetings with new staff will need to go ahead.

Speed Indicator Devices: Solar powered devices are costing between £2,500 and £3,000 and come in cheaper than the £8,500 electricity driven devices. This is something that can be investigated when considering further sites for SIDs around the town.

Usk Bridge: this has been hit again. Discussions with Cadw and Heritage are ongoing. Confirmation of the extent of the listing – All of the bridge that is seen. Any proposed changes would need Heritage and Cadw permission. Heritage are not in favour of any alterations to the bridge and would like other solutions investigated placing the emphasis on Highways. The bridge is get hit by back ends of lorries to avoid this, lorries need to cross the central line and oncoming traffic can hinder the correct manoeuvres. One of the issues is the signage; the view from Britannia signs is blocked by MCC signs. A proposal to move the signage is being considered and a keep clear zone has been discussed.

School Crossing: The fence has been repaired and road lines are to be changed.

SIDs: The one coming into town on Monmouth Road is to be repaired.

Car Parking Review: No update.

Parking Enforcement: MCC have had staffing issues with 3 staff down. A new Head of Enforcement has been appointed and will be hoping to have 3 replacement staff in place by November. A shift system will be introduced so officers will be working weekends. One Stop corner will be an enforcement hotspot.
