20.4 Areas of concern around the Town

Post Box in Bridge Street

UTC has requested that Royal Mail reinstate a post box in Bridge St. following the closure of the old Post Office. The request has been refused by Royal Mail on the grounds that "there are already three post boxes all within 440 meters of the post office and it is considered that the current post boxes cover all address points in the area. Additionally, Bridge Street is also only a two-lane road which is very narrow with Double Yellow lines along its length. The pavements are extremely narrow making collecting difficult and thus unsuitable for a pillar box "

Missing stone on Usk Bridge

20.5 To receive an update from the Community Communication Committee

Cllr Brown reported the following

- Following a visit to the "Visit Monmouthshire Team" at County Hall the new website with now have stronger links with Mon CC
- > Facebook has 617 likes and 175 followers on Twitter

Cllr Richards reported that communication from officers at Mon CC about notification of the proposed renewal of the Gas pipes in Usk were forwarded to Town & Community Councils at different stages throughout 2017.

20.7 To receive an update from Usk in Bloom

Cllr Kear thanked UTC on behalf of Usk in Bloom for the recent reception held in their honour. He also thanked Cllr Strong for his request to Mon CC for funding towards hanging baskets for "Champion of Champions". The following was reported

- > UiB is working hard towards Britain in Bloom
- UiB is considering entering the "World in Bloom" competition. Cllr Kear asked if UTC would consider paying the entrance fee of £850. A decision will be needed by 1st March 2018
- > Cllr Kear expressed concern about the flowers in Twyn Square during the Velothon
- > A number of members/administrators within UiB have been reduced due to various reasons

20.8 To receive an update on the proposed gas works by Wales and West Utilities

Cllr Richards reported the following

- Usk Town website and Facebook page has been updated. This coincided with a letter drop from W&W Utilities.
- ✤ All residents affected by "Clearways "have received hand delivered up to date information.
- Relative signage is in place.

The chairman thanked Cllr Richards for all her hard work in liaising with W&W Utilities and communicating with residents in relation to the gas pipe replacement/works.

20.9 To receive an update on parking facilities in Maryport Street, North car park following changes to the recycling centre

Cllr Leathwood reported that two additional car parking spaces have been identified. UTC are just waiting for Mon CC to mark these up.

Following discussion, it was suggested that a survey be conducted on the use of the car parks in Usk.

21.3 To update Councillors on the "Review of community boundaries and electoral arrangements"

It was reported that Mon CC has been asked by the Welsh Government to pick up from where the review of community boundaries and electoral arrangements were postponed due to the publication of the Williams report and the uncertainty of future mergers.

Resolved:

Mon CC will reconvene its working group and finalize its proposals based on feedback received at the previous consultation stage. It is hoped that Mon CC will approve the final proposals in April/May 2018 following which these proposals will be submitted to the Local Boundary Commission for Wales

21.4 To receive an update on the Local Development Plan Draft Review Report Consultation

Following on from the Cluster meeting with Mon CC Cllr Richards gave a presentation on the Local Development Plan Draft Review Consultation Report.

This was noted by Full Council. It was recommended by Cllr Richards that UTC give formal approval to new LDP proposals.
